

MEMORANDUM OF AGREEMENT Between



SCHOOL OF SOCIAL SCIENCES AND HUMANITIES, CAN THO UNIVERSITY, VIET NAM

and

FACULTY OF HUMANITIES AND SOCIAL SCIENCES, NAKHON PATHOM RAJABHAT UNIVERSITY, THAILAND

Both parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the further promotion and understanding of research, culture and student exchange. The purpose of this MOA is to define the areas for student and staff exchanges, research internships, and interested topics in which the parties desire to work together in the future for their mutual benefits to foster a collaborative framework between School of Social Sciences and Humanities, Can Tho University, Viet Nam and Faculty of Humanities and Social Sciences, Nakhon Pathom Rajabhat University, Thailand in the field with a view to benefiting from each other's initiatives and working procedures and

to support collaboration among the researchers associated with both parties.

Article 1

Both parties agree in the academic areas of common concern and by following the appropriate way to promote academic exchange and cooperation:

- Share experience, exchange visits.
- Exchange researchers and lecturers.
- Exchange students.
- Promote the joint research projects.
- Jointly hold academic conferences and other academic activities.

Article 2

This MOA shall be effective for a period of three years from the date of final signature.

Article 3

- Length of the Study: Semester or customized time frame based on mutual agreement.
- Courses:
 - Professional courses: Social sciences and humanities course, tourism and related courses.

- The credits from the host institution may be transferred to the home institution, subject to approval by the latter.
- Transportation: Airport pick-up and drop-off service.

Article 4

- As stated above, any specific joint projects with legally binding obligations will be set forth in separate written agreements.
- Treatment of intellectual property rights developed through collaborations under this MOA will be determined between the two parties through mutual consultation and separate written agreements on a case-by-case basis.
- Each party will be responsible for its own costs in connection with all matters.

Article 5

- This Memorandum of Understanding shall be effective upon the signatures of both parties.
- Each party will receive a copy for credential.
