



**MEMORANDUM OF UNDERSTANDING
ON ACADEMIC COOPERATION
BETWEEN
COLEGIO DE SAN JUAN DE LETRAN CALAMBA
AND
NAKHON PATHOM RAJABHAT UNIVERSITY**



NAKHON PATHOM RAJABHAT UNIVERSITY, THAILAND and COLEGIO DE SAN JUAN DE LETRAN CALAMBA, PHILIPPINES, recognizing the benefits to their respective institutions from the establishment of institutional links, conclude this Agreement.


1. The purpose of this Agreement is to develop academic and educational cooperation and promote mutual understanding between the two Academic Institutions;
2. Both higher educational institutions (HEIs) agree to develop the following collaborative activities initially in the field of Tourism and Hospitality Education, on the basis of equality and reciprocity;
 - a. Exchange of faculty;
 - b. Exchange of students;
 - c. Conduct of seminars/training related to the program;
 - d. Conduct of collaborative research projects;
 - e. Conduct of cultural exchange activities and immersion programs;
 - f. Exchange of academic information and materials; and
 - g. Promotion of other academic cooperation as mutually agreed.
3. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed upon between the schools and their respective faculties, which will carry out the specific projects. Both HEIs agree to carry out these activities in accordance with the laws and regulations of their respective countries after full consultation and approval with the proper government agencies.
4. It is understood that the implementation of any type of cooperation stated in Agreement number 2 may be restricted depending upon the availability of resources and financial support of the HEIs concerned. Any and all restrictions must be disclosed, in good faith, by both HEIs during the negotiation period of each agreement and prior to its implementation.
5. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both HEIs shall seek equitable and fair understanding as to the ownership and other property interests that may arise. This understanding shall be based on the laws, rules, and guidelines then implemented at each HEI's respective country.

6. This agreement may be amended or modified by written agreement, only with the consent of both parties as evidenced by the signatures of both HEIs' authorized representatives.
7. At the event of any unforeseen incident during collaborative activities in either country, both HEIs agree to negotiate a mutually acceptable solution and refrain from any legal action as agreed upon in Agreement number 10. As far as practicable, these solutions shall be incorporated into a specific agreement stated in Agreement number 3.
8. This agreement is valid for a period of three 3 years from the date of signing by the representatives of both HEIs. This Agreement may be renewed only – upon negotiation by both HEIs.
9. This Agreement may, at any time during the period of validity, be terminated by one of the HEIs, with at least three (3) months prior notice to the other in writing and not later than six (6) months before the termination date.
10. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the HEIs shall endeavour to exercise best efforts to negotiate their differences. A party must, as soon as reasonably practicable, give the other party notice of any dispute arising under or in connection with this Agreement and the succeeding Agreements as stated in Agreement number 2 and, in good faith, endeavour to resolve the dispute by escalating it to the higher levels of management. Alternative methods of dispute resolution shall be exhausted before resorting to court litigation. The mediator shall be agreed upon by both Parties. In case there is no settlement, both parties hereby agree that all legal actions arising out of this Agreement shall be instituted in the proper court in Calamba Laguna to the exclusion of all other courts. This Agreement and transactions contemplated hereunder shall be governed by the laws of Philippines.
11. This Agreement shall be executed in NAKHON PATHOM RAJABHAT UNIVERSITY, THAILAND, with English and Thai versions having equal validity.


