



MEMORANDUM OF UNDERSTANDING



between

NAKHON PATHOM RAJABHAT UNIVERSITY, Thailand, a State University recognized by the Royal Government of Thailand under Government Gazette No. 121, section 23A on June 15, 2004 (hereafter referred to as NPRU)

and

ST. MARY'S COLLEGE, QUEZON CITY, an International Organization for Standardization (ISO) certified school administered by the Religious of the Virgin Mary with address at 37 Mother Ignacia Ave., Philippines (hereafter referred to as SMCQC).

The Memorandum of Understanding establishes the following:

I. Scope of the Understanding

This MOU contains statements of intent but will not qualify as a binding agreement between the Parties. An agreement will be reached when both parties have negotiated, prepared and executed a separate written agreement establishing their binding obligations and approved by each Party's Authorities or Board of Trustees in relation to specific objectives stated below.

II. Objective of the Understanding

The Understanding establishes the extent of the academic cooperation between NPRU and SMCQC. The two parties agree to provide exchange of faculty and students, cultural exchange and professional internship in English with the aim of enriching their written and oral English communication skills in academic and social contexts.

III. Modes of Collaboration

NPRU and SMCQC shall endeavour to promote collaboration in the field of language and communication through different strategies, which shall include:

1. To enrich the educational environment of both parties;
2. To enhance knowledge, skills and expertise of faculty;
3. To exchange ideas and resources on teaching academic subjects using English as the medium of instruction;
4. To increase individual educational opportunities.

IV. Mutual Expense and Reliance

The host institution will be responsible for the living accommodations during the discussions in connection with this MOU, and all discussions shall be done in good faith for the mutual benefits of both parties involved.

V. Limitations and Liability

In no event shall either Party be liable to the other for any damages whatsoever including, without limitation, direct, indirect, speculative, incidental, special or consequential damages in connection with performance under this MOU.

VI. Duration of the Understanding

- a. This Understanding shall take effect on the date which it is signed by both Parties and shall continue to be in force for a period of three years. The duration may be extended by written agreement between two parties.
- b. Changes of the Understanding shall be made only with mutual consent of said parties. In cases of disagreement, the party wishing to terminate the understanding shall give six month notice of its intention.


